PENNSYLVANIA SKEET SHOOTING ASSOCIATION' S

HALL OF FAME

- I. A Hall Of Fame system is hereby instituted to honor those residents of the Commonwealth of Pennsylvania who have distinguished themselves by a high degree of proficiency in the sport of skeet shooting and/or by major contributions to the promotion and welfare of the sport, exhibiting in the process a high degree of sportsmanship and selflessness.
- II. In order that the Pennsylvania State Skeet Shooting Association's Hall of Fame will be administered on a consistent, just basis, free from temporary influences, and to reflect the perspective of time, the following rules and guidelines for its administration, and the selection of the recipients for such honors are set forth:
 - A. Selection of persons to be honored shall be made by a committee of three appointed by the President of the Pennsylvania Skeet Shooting Association. Committee members shall serve a three year term with one term expiring each year. The committee shall be anonymous, known only to the President.
 - **B**. All selections of persons to be inducted into the Hall of Fame shall be secret prior to induction, and no committee members shall make public any nomination considered or divulge any information concerning the committee deliberations. Upon selection by the committee, the names and necessary paper work shall be submitted to the president. The selections of the committee are final and are not open to review or veto.
 - C. The formal ceremony of induction into the Hall of Fame shall take place at The Pennsylvania State Skeet Championships. The major accomplishments of the inductee shall be included in the citation.
 - **D**. Each inductee shall be presented a suitable plaque or other memento of the honor.
 - **E**. A suitable plaque or picture shall be displayed in whatever location shall be designated for the purpose by the Board of Directors of the Pennsylvania Skeet Shooting Association.
 - **F**. The number elected to membership in the Pennsylvania State Skeet Shooting Association's Hall of Fame shall be:
 - 1. up to three members the first year of existence of the Hall of Fame.
 - 2. up to two members the second year and each year thereafter.
 - 3. at least one living member each year. There may not be any inductees in a particular year if no nominations are made.

shall be ruled and guided by the following:

A. SHOOTING PROFICIENCY

- 1. Only persons who have exhibited a high degree of sportsmanship in their shooting activities shall be considered, regardless of their other shooting accomplishments.
- 2. Any nominee being considered must have a shooting record for a minimum of twelve years, at least six of which must have been shot in the Commonwealth of Pennsylvania. During that six-year period, the nominee must have met the state minimum target requirements. Exception to the twelve years can occur in cases in which untimely death or disablement terminated an active shooting career. In such cases, a minimum of eight years may be considered.
- 3. The nominee shall have won a minimum of five championships either High-Over-All or Gun Championships, achieved State Team or High Average First Team, or accomplished any other major shooting feat. (Championships are defined as titles being won at the World Shoot, the Zone shoot, the State shoot, or any other major shoot.)

B. <u>ADMINISTRATIVE EXCELLENCE</u>

- 1. Only persons who have exhibited a high degree of sportsmanship in their administrative activities shall be considered.
- 2. Any nominee being considered must have performed outstanding work for skeet shooting in Pennsylvania over a period of twelve or more years, except in cases of untimely death or disablement terminating an active administrative career. In such cases, a minimum of eight years may be considered.
- 3. The nominee's work must have been undertaken in a voluntary manner and must not have occurred while the nominee earned a living in the skeet administration field.

C. <u>ADMINISTRATIVE/SHOOTING EXCELLENCE COMBINATION</u>

Persons who do not wholly qualify for induction under either **III-A** or **III-B** may be considered based upon a combination of **III-A** and **III-B**.

VI. OTHER CRITERIA:

A. All inductees must have been a resident of the Commonwealth of Pennsylvania for a period of twelve years, except in cases of untimely death. In such cases, a minimum of eight years may be considered.

- **B**. A nominee may be deceased, retired from serious competition, or still active.
 - 1. If a nominee is deceased or retired from serious competition, he/she will

- not be eligible for consideration until two years after death or retirement.
- 2. The nominee's record prior to the last two years may be considered for any nominee that is still active in competition.
- **C**. A nominee who is considered and not selected may be reconsidered an unlimited number of times.
- **D**. Industry Representatives shall not be excluded from consideration provided that any contributions made were above and beyond the requirements of his salaried position.
